Angelica Morones-Harris	With my 19 years of experience in the office I have seen some areas that I think could use some improvement. First, Cross train all the office staff so that we can better serve the public's needs. Our documents are important and should not be delayed because the responsible person is out sick, on vacation or dealing with family needs. Second, improve payment options to improve collections. When the court isn't collecting payments, it has lost revenue and the county must track down payments. This costs taxpayers money. Currently our office only accepts cash & checks at our office so if someone comes in to pay by credit card we have to send them home to go pay online. Third, I will work to better collaborate with the Judges and other county offices for improved processes and communication. How we process between our judges and other county offices must be more efficient. Employees should not have to work to track down documents or information they need. Judges and county offices face the same challenges from time to time. By improving the process and communication we can make everyone more productive and this saves taxpayers money.
Barbara Pousson	My three goals: Technology: Maximize the use of all available technology, e-filing, scanning, docket and being paperless. As clerk of the County Court we use everything that we can to the fullest to help with the office workflow. In using all this technology, I have been able to cut 1 full time position in my office. In County Court I am paperless in the Civil division, I have been e-fining in the Civil division since 2006, we were the pilot for the state of Nebraska. Customer Service: With the increase in Pro Se "Self represented Litigants" more customer service is required. More care is given when dealing with these cases, more phone time and guidance. #### [ACTIVITIES] Describe the various activities/responsibilities of the position.

Paul Cook	Candidate has not submitted an answer.
Dori Heath	The Clerk of the District Court administers and maintains all official court records, files, and records of proceedings for the district and juvenile courts, as well as records for the Mental Health Board. The cases consist of felony criminal cases, domestic cases (dissolution of marriage and paternity/support cases), civil cases over \$53,000, construction liens, appeals from county court and protection orders. The District Court is responsible for the selection of both civil and criminal juries in addition of appeals to the Court of Appeals and the Supreme Court. The District Court Clerk is tasked with compiling and computing the IV-D reimbursement funds on a quarterly basis, managing the passport acceptance staff and the yearly submission of the budget for the office. The District Court Clerk's office is responsible for collecting and disbursing court funds for spousal support, monetary judgments, bail, foreclosures, fines and other court costs. In a typical year the office processes over \$5 million.
Angelica Morones-Harris	The Clerk of the District Court performs administrative duties for the court. Some of those duties are being a record keeper for all the District Court files and also of the Juvenile Court files. Managing a staff of 13 people. Keeping track of the budget for the office. Manages time cards to submit to payroll department. Helps with the jury when there is a jury case in District Court. Manager of all the passport agents in the office. Helps get the process started for judicial bypass paperwork. Manages and processes the mental health cases.
Barbara Pousson	The District Court hears all felony criminal cases, equity cases, domestic relations cases, and civil cases involving more than \$52,000. It also functions as an appellate court in deciding appeals from county courts and various administrative agencies. The Clerk of the District Court, besides being the administrative officer of the court, is responsible for the record keeping and collection of child support payments, the record keeping of criminal and civil cases, maintenance of the court's dockets, processing judgments, and verifying passport applications. The District Court clerk has a staff of 14 clerks, the Clerk is responsible maintaining the management of this staff. Also creating and maintain a yearly budget.

Dori Heath	Of my 34 years working in Nebraska's court systems, I have nearly 16 years managing people and operations in District Court. No other candidate can make that claim. Furthermore, I don't solely manage so much as I provide "leadership" and "empowerment" to my team. This is a big distinction in my candidacy and is why I historically have no turnover in District Court as the Clerk. Additionally, my education has also been a factor in developing my skills. I am a lifelong learner and I recently completed my Master's of Science in Negotiation & Dispute Resolution from Creighton University in 2016. This was a natural fit for my demeanor, my ability to work with others and to see the other person's perspective. The lessons learned in that program not only helps in the field of mediation & conflict resolution, but also as a supervisor and leader. It gives a perspective that helps one understand the importance of the other's position and interests; allowing me to create a framework for dialogue and more openness, in and out of the District Court.
Angelica Morones-Harris	When I was 18 years old and just about to graduate high school, I worked at a retirement home in Roswell, New Mexico as a dietitian assistant. While working there almost 2 years I was asked to be the supervisor of the kitchen staff because the current management was moving over to the new building and they needed a new management staff at the current building. I accepted the supervisory position but after graduation came to visit my sister who lived in Bellevue at the time and ended up falling in love with Nebraska and have lived here ever since. In September of 1996 I began working at the Offutt Air Force Base Exchange (BX). I first began working there as a cashier and then I moved to the outdoor living/toy department. Then about a year or so later I became the night cashier supervisor. On February 22, 1999 I began working at the Sarpy County Clerk of District Court office. I first started out as a Clerical Support Specialist. While in this position I liked helping others when they needed it so I would jump in and learn other people's jobs to help them out when I could. Dori Heath	The District Court is an integral part of our judicial system and much more complex than county court, which deals with speeding tickets, misdemeanor and small claims cases. The cases in District Court are serious in nature and it is imperative for the plaintiff, defendant, judge and taxpayers, that records are organized and managed for accurate storage and retrieval as cases are opened, closed and reopened, potentially many times. Running an error-free District Court requires establishing and maintaining processes that insure the office executes its duties efficiently and fairly to all citizens alike. The only partisan aspect of District Court is this election. Otherwise, it is the duty of this office and the court to check partisanship at the door and simply follow and execute the responsibilities of this office using established processes, state statutes and reasoning based on law. I have extensive experience managing District Court on all levels as a former Clerk of the District Court where I was elected 4 terms. Here in Sarpy I have been the the Chief Deputy (2nd in command) for over 14 months.
Angelica Morones-Harris	My goal will be to do a complete review of policies to ensure they are performed in both the best interests of the citizens and the court system we administer. I believe there are many procedures that can be updated to better serve

these interests. I also believe there can be many administrative changes that can be made to make the office more efficient and effective. Barbara Pousson I will do my best to serve everyone that has a need to come and do business with the courts, also to be a good leader that the County can be proud of.
